Chico Country Day School Admission policy:

- Students will be considered for admission without regard to race, ethnicity, national origin, religion, gender, sexual orientation, perceived sexual orientation, home language, or disability.
- Preference will be given to siblings of currently enrolled students and to children of staff members.
- A separate application must be completed for each child.
- Parent/Guardian must guarantee that this application is completely filled out and the information provided is accurate. If the information is misrepresented, the child will be subject to dismissal. **If a child has an IEP, this application is invalid without a copy of the current and signed IEP attached.**
- Parents/Guardians are responsible for understanding CCDS admission policy and for informing the school of changes in contact information.
- Prospective Kindergarten students must be 5 years old by December 1, 2011.
- Lottery for all grades will be Friday, January 15, 2010, at 1:30pm. Parents are welcome to attend.
- In the Spring, current CCDS families will be asked if they intend to return in the Fall.
- As openings occur, families on Wait List are notified by phone and given 24 hours to respond to the offer for placement. Supplying the school with alternative numbers and e-mail address information is encouraged.
- If a child is offered a position and parent/guardian declines, child will be deleted from the wait list unless parent/ guardian asks that s/he be placed at the bottom of the wait list.
- Kindergarten provision: If a Kindergartener is selected in the lottery, registers and begins school, but in the opinion of the teacher and the parent is not yet ready for kindergarten, the child may be disenrolled from school for that year. The following year s/he may be re-enrolled without having to go through the lottery process again.
- A student can only be enrolled at one school; should another school request student's records after parent/ guardian has accepted placement at CCDS, student will be dropped from CCDS' class list and his/her records forwarded to the requesting school.
- Wait Lists are not carried over to the following school year. **A new application MUST be completed each year.**
- Student must agree to follow attendance and behavioral standards outlined in the Student-Family Handbook.
- Students with SARB (School Attendance Review Board) contracts will be expected to complete the terms of their contract before being considered for admittance to CCDS.
- Students will not be admitted to CCDS if under an expulsion determination from previous school.
